## Role Summary

The Database Quality Assurance Manager will lead teamwide efforts to ensure the FARM Program maintains accurate, complete, and up-to-date data. The Manager will work with FARM Program participants to make certain data entry and database administration best practices are being properly executed. The Manager will be responsible for working with the Stakeholder Relations Manager on outreach and customer support to dairy cooperatives and processors to monitor, assist, and where appropriate, intervene to maintain the high standards of the FARM Program. In addition, the Manager will work with an external database consultant to build system monitoring and controls, in order to safeguard proper administration of randomly sampled third-party evaluations.

## **Role Responsibilities**

- Provide support to all FARM program participants and stakeholders in relation to database inquiries and needs
- Develop and maintain processes for the design, communication, validation and maintenance of data and functionality of the FARM database
- Develop and prepare detailed monthly and quarterly data summaries to enhance communications and educational materials
- Conduct regularly scheduled oversight, statistical analysis and management of program data
- Work collaboratively with all FARM team members and database consultant to oversee task priorities related to the FARM Program database and mobile entry apps
- Coordinate with the Stakeholder Relations Manager to manage and organize database needs in accordance with FARM Program standards and guidelines
- Supervise the selection, administration, and communication of FARM Program third-party evaluations
- Other duties as assigned

- Bachelor's degree in Agricultural Economics, Agribusiness, Animal Science, or Data Management related field of study preferred
- Familiarity with agriculture and/or the dairy industry strongly preferred.
- Proficient in Microsoft Office (Excel, PowerPoint, Word).
- Strong communication skills required.
- Strong attention to detail required.
- Strong understanding of data analysis and database management required with previous experience preferred.
- Familiarity with database management software/web services helpful, but not required
- Ability to work collaboratively with a diverse group of internal and external stakeholders.
