

## Year in Review Spotlights FARM Program's Growth

The FARM Program <u>released</u> its 2021 Year in Review highlighting new initiatives and program area advancements.

#### Animal Care Task Force Considers Version 5 Updates

The Animal Care Task Force has been meeting bimonthly since Summer 2021 and has begun meeting monthly since January to discuss the key areas identified for consideration from the FARM Animal Care Version 5 industry-wide feedback survey. Beginning with Animal Based Outcomes, the Task Force, to date, has discussed considerations around:

1. Revising the Body Condition Score scale

- 2. Instating a Continuous Improvement Plan (CIP) associated with the Hygiene benchmark
- 3. Revising the Broken Tail scoring guidance and benchmark
- 4. Developing a benchmark for moderate lameness (score 2)

From these discussion areas, the following recommendations will be put forward to the NMPF Animal Health and Well-Being Committee for their consideration:

- **Body condition**: No change to scoring (maintain 1-5 scale)
- Hygiene: CIP should NOT be applied
- Broken tails: Benchmark and Scoring Guidance considered, tabled until March meeting
- Locomotion: Establish a moderate lameness (score 2) benchmark with associated CIP creation, benchmark to be determined after thorough literature review to be reviewed at March meeting.

The March Animal Care Task Force meeting will focus on the remaining Animal Based Outcome areas tabled and begin discussions related to pain management. Other topics that will be discussed in upcoming task force meetings, as informed by the survey and on-going feedback, will include calf management, fitness to transport, euthanasia, record keeping, continuing education, willful mistreatment thresholds and animal observation scoring sampling approach.

#### **Environmental Stewardship Evolves in Version 3**

NMPF and the Innovation Center for U.S. Dairy are collaborating to update the greenhouse gas (GHG) model that powers FARM ES. With the launch of FARM ES Version 3.0 in 2024, the program will transition to a "processbased" model through work with RuFaS – an initiative involving researchers from across the country focused on environmental modeling of dairy farms. Shifting to a process-based model offers several benefits for addressing customer requests while offering more insights to farmers and FARM Participants:

- A more robust and accurate model, while remaining practical and easy to use
- Farm-level environmental and economic insights through scenario analyses to support informed decision-making about the adoption of practices and technologies
- Increased functions to enable farmers, cooperatives, and processors to work with supply chain customers interested in investing in on-farm interventions and GHG reductions

Through this upgrade, FARM ES will be positioned to better support the dairy community's efforts to achieve its 2050 environmental stewardship goals, including to become GHG neutral or better. Stakeholder engagement and

# New in 2022: Quarterly ES and WFD Evaluator Discussion Groups

The FARM Program is launching Quarterly Evaluator Discussion Groups for FARM Environmental Stewardship (ES) and Workforce Development (WFD) evaluators in 2022. These 45-minute Zoom calls are voluntary and will allow the FARM evaluator network to exchange ideas and best practices on ES and WFD program implementation. Sessions will also feature subject matter experts and topical discussion for continuing education opportunities. The first WFD Evaluator Discussion Group on April 7 will highlight the topic of Onboarding and Orientation practices with Cornell Professor, Dr. Richard Stup. The first ES Evaluator Discussion Group will follow on April 22, highlighting V3 development plans and common ES questions. #### **Town Hall Scheduled for Animal Care Version 5**

FARM Animal Care standards are revised every three years to reflect the most current science and best management practices within the dairy industry. Standards, rationale, and accountability measures are reviewed and revised by the FARM Animal Care Task Force and NMPF Animal Health and Well-Being Committee with input from industry stakeholder groups including farmers, animal scientist and veterinarians. FARM is currently in the process of facilitating the development of <u>Animal Care Version 5</u>.

the livestock industry and improve animal welfare. They can be a tool to communicate about animal care to consumers. The Professional Animal Auditor Certification Organization (PAACO) is offering a Dairy Welfare Auditor Training March 28 – 31 via Zoom.

# Stewardship Commitment Demonstrates U.S. Dairy's Positive Impact from Farm to Table

The U.S. Dairy Stewardship Commitment is a voluntary, stakeholder-aligned initiative to advance sustainability leadership across the dairy community. It aligns and quantifies industry action on important areas like the environment and animal care to affirm and illustrate U.S. dairy's longstanding values of responsible production, nourishing communities, and continuous improvement.

Cooperatives and processors that adopt the Stewardship Commitment agree to work collaboratively with diverse stakeholders and follow a rigorous set of standards to demonstrate a positive impact. On a broader scale, adopting companies support and contribute to U.S. dairy's ability to track, aggregate and report on national progress. #### Human Resources Checkup: Timekeeping System

Timekeeping refers to the methods used by employees to accurately record the time they work, including start times and end times. The timekeeping process should include getting both employee and supervisor signoffs on the timekeeping submitted for payroll each pay period prior to processing. This ensures workers and supervisors agree on hours worked and employee paychecks are accurate.



Check-up:

- Does the farm have a timekeeping system that lets employees and their managers review and confirm the hours worked for each pay period?
- Are rest and meal breaks documented, for example, through a break relief schedule or within the farm's timekeeping system?
